The Last Decade of Western
The formation of MCI was a result of a series of events that began in 1980 when Robert E. Kahn, a former Bell Labs researcher, and John T. Dunlop, a former AT&T executive, founded Western Union. Kahn and Dunlop were looking for a way to break the monopoly of the Bell System and create a new, more competitive telecommunications market. They saw the potential of a new, more efficient and cost-effective way to provide long-distance telephone service. In 1981, they formed Western Union, which was initially a holding company for a number of other companies, including Western Union, Western Union International, and Western Union International. In 1982, Western Union was reorganized as a public company and renamed MCI Telecommunications Corporation. In 1983, MCI was listed on the New York Stock Exchange.
