 - d) As a side note AT&T will no longer be maintaining wire phone lines after 2018.
 - e) Bill spoke about the 4 phases of disaster preps at the county level, and mitigation of the effects of a disaster
 - i) What what are the potential threats. Fire, power loss, earthquake, etc.
 - ii) How to mitigate the effects of these threats. Self–sufficiency for 72 hour minimum is recommended. Food, water, clothes, shelter, medicine, hygiene, pet food, etc.
 - iii) When to decide course of action and initiate. Evacuate, remain in place.
 - iv) Aftermath post disaster actions.
