### **Calaveras County Public Health Officer Issues Local Order and Emergency Regulations**

To protect the health and well-being of all people living in Calaveras County, the Calaveras County Public Health Officer is ordering that all individuals living in Calaveras stay home, except as needed to maintain essential business and governmental operations. This order goes into effect immediately. This order is in place until further notice.

Essential services will remain open, such as:

- Gas stations
- Pharmacies
- Food: grocery stores, farmers markets, food banks, convenience stores, take-out and delivery restaurants
- Banks
- Laundromats/laundry services
- Essential local government functions will also remain open, including law enforcement and offices that provide government programs and services.

Non-essential services should be closed immediately, such as:

- Public events and any gatherings
- Dine-in restaurants, bars, wineries, tasting rooms
- Churches and places of worship
